BUSINESS PLAN

There are four essential ingredients in any Chamber of Commerce: volunteers, finances, staff and a business plan. The basis for the organization is the business plan which is defined as "the sum total of programs and activities currently being carried out by the Chamber of Commerce." The preparation of the business plan, or the Chamber's "action plan," is possibly the most important responsibility of the Board of Directors.

Each year, the Chamber board sets goals and prioritizes areas of need. Some of the Chamber programs that have evolved from this format include the annual Chamber Gala, Business After Business, the Dixon Collectible Series, our Drug Free Workplace Program and Testing Initiative, and the Chamber website. Each of these initiatives has addressed an opportunity expressed in our annual planning exercise and influenced by our networks with other community leaders.

The following are abbreviated portions of the Dixon Chamber's continuing Business Plan.

COMMUNITY PROMOTION

The Chamber acts as the business advocate and “front door” for the community. Each year we handle thousands of requests for information regarding our community. We provide Community Profiles and View books and expose our members to countless newcomers. The Chamber office is regularly visited by business men and women, tourists and other travelers seeking information about the community. A Chamber produced map of Dixon and Lee County is available as are tourism brochures and information about area events. The Chamber truly is the ambassador for Dixon.

PARTNERS IN EDUCATION

The Chamber is the main conduit to the business community for the award-winning Business Education Community Partnership. Chamber members have served on all committees of this organization since its creation in 1989 by the Dixon (now Lee County) Industrial Development Association. The Chamber encourages our members to participate in partnership activities with the schools. We advocate getting students and educators into the business environment and business persons into schools so that each may experience the other’s daily environment.

THE “VOICE” OF BUSINESS

Through the Dixon Chamber’s legislative affairs programs, the Grassroots Action Center of the Illinois Chamber, and the U.S. Chamber’s advocacy network, we track pending legislation which affects Chamber member’s cost of doing business. Leveraging the voice of business with contacts to legislators, we provide you with the background materials you need and provide the key contact information for legislators that need to hear from you.

The Chamber conducts periodic legislative and candidate forums to inform our members and the public about local candidates and important issues.

SMALL BUSINESS PROGRAMS

Noting that small business generates a great deal of growth potential in our area, the Chamber provides several programs geared to this segment of our membership. Quality seminars are offered on selected subjects throughout the year intended to provide business owners with information close to their businesses.

The Chamber works closely with the Small Business Development Center at Sauk Valley Community College in providing support for existing businesses as well as start-ups. In addition, the Chamber offers a myriad of demographic and business resource information available to assist businesses in making crucial development decisions.

COMMUNITY GROWTH

The Chamber helps create job opportunities through the stimulation of industrial and commercial growth. We seek improvements in community infrastructure and human resources. The Chamber works in partnership with the Lee County Industrial Development Association, Dixon Main Street, the City of Dixon and others, to foster growth, new development, and business retention.

U.S. Chamber Federation Membership

Drug-Free Illinois Workplace Program

This program is designed to increase the number of small and medium-sized businesses in Illinois who initiate a drug-free workplace program with policies and procedures. The Dixon Chamber is a sponsoring local Chamber of this program in cooperation with the Illinois Chamber.

Dixon Chamber members may be eligible to receive drug-free workplace policy assistance or substance abuse awareness training and/or supervisor training at no cost.

Chamber Ambassadors

The Chamber Ambassadors, a group of 30 of our best volunteers, function as a good-will organization to develop a better overall image of the Chamber. Ambassadors serve as hosts at Chamber events and welcome new businesses at ribbon cuttings and open houses. This provides Ambassadors first access to many of the new businesses as they locate in the Dixon area.

Ribbon Cutting Service

The Chamber's Ribbon Cutting Service, using our big scissors, is the perfect way for your new business to get noticed. The ribbon cutting results in a "free" ad in the local newspaper highlighting your business.

Access through Networking and Referrals

Members may take advantage of the Chamber network through our *Membership and Business Directory* and our monthly newsletter, *Dixon Area Business News*, published monthly and available for viewing on the Chamber's website. Businesses may effectively advertise to over 500 key business contacts through this exclusive Chamber resource.

- 1887** Citizens Association of Dixon incorporated.
- 1912** Charter Member of Chamber of Commerce of the United States of America.
- 1915** Citizens Association name changed to Chamber of Commerce.
- 1920** Chamber reorganized under American City Bureau . . . retains Chamber of Commerce name.
- 1925** Member of Illinois Chamber of Commerce.
- 1926** Moves to a City building located along the Rock River close to the Abraham Lincoln Bridge.
- 1997** Chamber President (John R. Thompson) elected to serve as President of the Illinois Association of Chamber of Commerce Executives.
- 1998** Chamber contracts with Lee County Industrial Development Association (LCIDA) to provide management responsibilities for the development association.
- 2000** After 74 years at its previous site, Chamber moves to a modern office building located in the heart of downtown Dixon. The site of the previous building was acquired by the State as part of a bridge reconstruction project.
- 2011** We celebrate our 125th year promoting the Dixon Area!
